COMMON ORDER ON 22 REPRESENTATIONS

Sub: Order on the Representations submitted by 22 Members of PDCA who have been declared as defaulter and their Right to vote and Right to Contest have been suspended till further orders...

1. During the Process of hearing the Objections on the Members List, 26 Defaulter Members, right to vote & contest have been suspended in the Ongoing Elections as per the provisions in the Constitution of PDCA for free, fair, and transparent elections.
2. Out of these 26 Defaulters, 22 Defaulters have made Representation to the E.O. seeking cancellation of their suspended rights pleading several reasons. These all representations have been sent on email of the election officer, but no physical copy have been submitted in the PDCA Office.
3. All these 22 Representations have been considered today, being the last day of Nomination.

On perusal of PDCA records it is seen that,

- A) Managing Committee, vide its meeting in 2025 has passed resolution on the 52 members, whose annual affiliation fees were outstanding, issuing notice to pay outstandings immediately. Accordingly, they put the notice on the Notice Board of PDCA.

- B) Managing Committee vide its meeting dated 06/05/2026 have passed resolution with respect to 26 defaulting members as on that date and declared them Defaulter as per their Constitution. They have also observed in the resolution that these 26 members have defaulted for many years, are continuously absent for the meetings, not participating in the cricket games /contest and are acting contrary to the objective of PDCA.
- C) The five objections raising Members, in their hearing argued that actions be taken on all the defaulters who have not paid the affiliation fees. Thus, the PDCA records were inspected in detail.
- D) When E.O. inspected the records, it was revealed that total 26 members are defaulters and their outstandings are for longer periods as below,

E) It is also seen that Objection raising five Members namely Shri Bhushan Deshpande, Shri Jayant Bhosale, Shri Prashant Satav, Shri Bharat Marwadi and Shri Kirtiraj Wadekar, pleaded for action against the defaulters. Now, records show that they themselves are defaulters under action; and now are representing for cancellation of the action.

Order:

Considering the facts of the matter and issue in consideration; since these 26 members have already been declared defaulters the suspension of right to vote and contest have been ordered in view of Rule 10, Rule 12, and Rule 15 of the Constitution of PDCA all the 22 representations are rejected.
